

2015 Annual Election **Gets Underway**

All members wishing to run for Council must submit petitions

he 2015 Equity election is just around the corner, and now is your chance to step up and be a part of the action. Active members ensure that Actors' Equity continues to be a strong member-driven union. Consider running for a seat on Council to have a voice in representing your fellow actors and stage managers.

16 Council and Eight Officer Seats Open Seats Available

There are a total of 16 Council seats open in this year's election. In the Eastern Region Principal category, there are eight seats for three-year terms. Also in the East, under the Chorus category, is one seat for a three-year term. There are two Eastern Stage Manager seats available this year, also with a term of three years. In the Central Region, there is one three-year Chorus seat and one three-year Stage Manager seat available. (There are no Principal seats available this year in the Central Region.) In the Western Region, there are three, three-year Principal seats available. (There are no Western Chorus or Stage Manager seats available this year.)

This year, in addition to the Council seats, the eight officer seats are also open. There are five national officers: president, first vice president (a member qualifying in the Principal category), second vice president (a member qualifying in the Chorus category), third vice president (a member qualifying in the Stage Manager category) and

secretary/treasurer. There are also three regional officers, one regional vice president for each of Equity's geographic regions (Eastern, Central and Western). All officers serve for a term of three years.

Candidate Qualifications

General Criteria: In order to be eligible to run for and hold a seat on the Council, a member must have been a member in good standing for the two years prior to nomination and currently be in good standing at the time of the election. Candidates must be at least 18 years old, and not be in a conflict of interest, or be under fine or suspension. Candidates must reside in the region from which they are seeking election and must meet employment category gualifications for the position they seek.

Principal Councillor Criteria: In addition to meeting the general criteria, a candidate running in the Principal category

must be a member in good standing, who has performed Principal work under no less than two Equity contracts or who has worked no less than one Equity contract performing principal work for no less than ten weeks.

Chorus Councillor Criteria: In addition to meeting the general criteria, a candidate running in the chorus category must be a member in good standing who has performed Chorus work within five years preceding the nomination or appointment to office (for the 2015 election, this date is June 1, 2010), provided the member has not worked as a principal performer for a total of 52 weeks within two years prior to such nomination or appointment to office (for the 2015 election, this date is

Stage Manager Councillor Criteria: In addition to meeting the general criteria, a candidate running in the Stage Manager category must be a member in good standing, who has worked as a stage manager five years preceding the nomination or appointment to office (for the 2015 election this date is June 1, 2010); (1) under Equity contract for at least 30 weeks solely as a stage manager or assistant stage manager; or (2) under no less than five Equity contracts solely as a stage manager or assistant stage manager.

Becoming a Councillor

All nominations to hold a seat on the Council shall be made by petition on the Official Equity Nomination Petition Form, which can be picked up in person at any Equity office or is available for download at the Equity website (www.actorsequity.org), beginning Friday, February 6, 2015, at 12 p.m. Eastern Standard Time. If you wish to be nominated, you must obtain the signatures of 17 members in good standing from the region in which you reside. In addition to the petition, you must submit all administrative forms found in the packet, as well as a letter of intent, requesting such consideration, to the Equity office in your geographic region. Your letter of intent should state (1) you are a member in good standing resident in the applicable region; (2) you are eligible to run in accordance to the Constitution and Bv-Laws:

Tax News: AtVITA, It's all about IDs, Health Insurance Info...and Other Updates

ocial Security cards will still Sbe required.

If you use VITA services this season, you'll have to bring vour Social Security card - or a photocopy of it - along with your paid-up union card and a current photo ID. SS cards must be provided for you and anyone else who is listed on your return, including your spouse and your dependents. This is the same procedure we've been fol-

lowing, so nothing's changed in that regard, and it remains the rule, even if you've had your taxes prepared at our center in the past. If you cannot locate your SS card or those of your spouse and/or dependents, you may obtain another from the Social Security Administration by visiting an office or going online to ssa.gov. VITA must comply with this procedure, so be prepared when you come in for your taxes or risk being turned away.

Health insurance forms will also be required.

This year, the Affordable Care Act provisions begin to appear on your tax returns in the form of a declaration of your health insurance coverage for the past year. If you enrolled for coverage on the exchange, sometimes referred to as the marketplace, you'll have to provide the preparer with Form 1095-A, which you'll be receiving in the mail at the same time you receive your W-2 forms and

1. New tax rates are in effect for 2014. 2. Affordable Care Act (ACA):

As noted above, this provision is in effect for the 2014 tax year. For most taxpayers, it is a "check the box" requirement. For those who purchased through the exchanges, qualified for subsidies, received any advance reduction in premiums or who were uninsured for any part of the year, you will have additional reporting to include on your tax returns. Some may be getting additional refunds. while some may face penalties for underinsurance. The IRS expects millions of additional telephone inquiries during the filing season and reminds taxpayers that the waiting time on these calls may be an hour or more.

3. Same-Sex Marriages, while recognized federally, might not be recognized in the

4. Standard Mileage Rates for 2014. Business mileage is 56¢/mile; medical and moving mileage is 23.5¢/mile; Charitable mileage is 14¢/mile. In 2015, the rates for business mileage will be 57.5¢/mile, medical and moving will decrease to 23¢/mile. Charitable mileage remains at the statutory rate of 14¢/mile.

5. Social Security Tax wage base is at \$117,000 and will rise to \$118.500. The rate stavs the same at 6.2 percent.

B. Educators' above-the-line deduction of \$250 (for K-12 teachers) is still in effect for those who qualify for this deduction for 2014.

C Charitable donations from IRAs. Those taxpayers over 70 1/2 years old, who made direct contributions of their IRA to charities, may exclude those contributions from your taxable income again in 2014.

D. Energy Credits. Those popular tax credits for installing new windows, doors, furnaces, insulation materials and other energy-saving improvements to vour home are still available through 2014

E. Expensing your business and related equipment remains at the \$500,000 maximum for the year. Be aware that you may only claim 100 percent of the cost if there is no personal use of the item. Otherwise, you apportion the business deduction for the amount you use the item for business.

F. State and Local Sales Tax

G. Tuition and Fees Deduction above-the-line is still allowed for 2014 up to a maximum of \$4,000. Don't forget that tuition and other valuable education credits remain for taxpayers who attend college and pay out-of-pocket. See which method is better for you this year.

H. Interest on Mortgage Insurance Premiums continues as an itemized deduction in 2014.

Resources Available for Actors Subjected to Sexual Harassment

iscrimination and sexual harassment are illegal, and no one should have to tolerate it. Yet, some Equity members working on contract might not be aware of the options that are available to them if they've been subject to sexual harassment or discrimination Your union is here to protect you from violence, harassment and discrimination in the theatres where you work. If you believe that you have been subjected to working conditions that cross the line, here's what you should know.

Sexual harassment and discrimination are against the law, which means that if you have been subjected to unlawful behavior, it's possible to file an individual lawsuit against an employer for violations of the law. Moreover, in some of the more extreme circumstances, conduct may rise to the level of a criminal violation. Sexual assault, for example, is punishable as a criminal offense, whether or not it occurs in the workplace. For many reasons, however, people who've been victims of sexual harassment and discrimination may not wish to file charges or a lawsuit. If those individuals are union members, they have additional options.

All Equity collective bargaining agreements contain provisions that prohibit discrimination and sexual harassment. In cases where those provisions are violated, Equity can pursue remedies through the grievance and arbitration procedure of the contract. The grievance process is a private process and information is held in the strictest confidence. While arbitration provides a final and binding remedy, the private nature of the proceeding means that there are no public records that can be accessed by anyone. The investigation, as well as any decision or resolution is kept confidential and is completely private.

In addition, your union can

help direct you toward other resources to assist members who have found themselves in difficult circumstances. Equity works closely with The Actors Fund to ensure that members have access to counselling and other services when they need them the most.

Remember that if you're ever in the situation of being the victim of violence. harassment or discrimination in a theatre while working on an Equity contract, your union is ready to stand by you. Any member who has questions or concerns should not hesitate to contact his or her business representative, in strict confidence. Equity will maintain confidentiality of all sensitive information, and the union never pursues a matter without explicit authorization from a member. Letting Equity know if something happens to you is important. You may not be alone, and by reaching out to us, we may be better able to protect other members who are in the same situation.

From the -PRESIDENT Wait 'Til This Year!

n baseball, the cry of those who do not win the championship is "wait 'til next year!" After several championship-level years, my fantasy baseball team set a league record for futility in 2014. Well, it's a new year, and in my own quiet presidential way, I'm excited — at least about Actors' Equity. For one thing, Equity News turns 100 this year. Like our industry, our union periodical has changed a lot in the past century. (If you're reading our mobile-friendly version on your mobile device: #EquityWorks! Tweet me @YmanNick).

Equity News is now just one of the ways AEA communicates with its members. Membership meetings, our AEA website. snail mail. email blasts. Twitter. Facebook, Instagram all give the leadership and staff of Actors' Equity a variety of ways to inform the membership. Members use many of these same methods to communicate with AEA, and we are reaching out even more in 2015. We are surveying members, using focus groups and holding town-hallstyle meetings, all in an effort to solicit and develop new ideas.

strategies and solutions for 2015's initiatives

After (appropriately) spending eighty-some years communicating with 20thcentury methods, AEA is embracing the technology of the 21st century to elicit the concerns and suggestions of our members and to inform them of our plans and goals and the progress we are making toward those goals. It's this progress that has me excited.

Nationally, we are gearing up for the negotiations of our flagship contract - the Production Contract Contract proposals and suggestions are being solicited not just from the Production Contract Committee members, but from everyone who has worked on the Production Contract in the past two contract cycles. We are holding not one, not two, but three special informational Town Hall meetings in the next two months: one on Touring, one on Stage Management and one for Broadway casts.

In Chicago, our informational, consciousness-raising campaign about whether the touring musical in a local theatre's "Broadway" series has professional Equity performers or not - #AskIfItsEquity - has

been so successful that Council is looking at expanding it nationally.

In Los Angeles, we are building the future, physically and metaphorically. We have constructed a gorgeous new Actors' Equity building with offices, meeting rooms and state-of-the-art audition facilities. We have hired a new Western Regional Director, a brilliant labor professional from SEIU named Gail Gabler. We continue to solicit the input of our members about the local Equity contracts and agreements. We held a special Town Hall meeting, attended by myself and four of your other elected officers, on January 12, 2015, about the 99-Seat Theatre Plan. We have taken steps to consolidate and streamline our committee structure. Our national contracts now have one national committee - rather than three regional committees so a question or a concession request doesn't get three different answers. We are taking advantage of telephone and video connections to make member participation on committees easier from outside the office cities.

Annual Report to the Council from the Equity Pension & Health Trustees

he Equity-League Pension plan remains in the "green zone" and is well funded. The most recent actuarial valuation shows that as of June 1, 2014, our plan has a funded percentage of 120.7 percent with an actuarial value of assets of \$1.6 billion.

After the global market meltdown of 2008, the trustees of the Equity-League Pension Trust Fund voted to take advantage of the Pension Relief Act of 2010 that offered an extended time period to recognize the losses of 2008-09. We were not permitted to make pension improvements while operating under that legislation. However, we will soon exit from that status and are beginning the process of working with our actuarial advisors to consider our options.

Meanwhile, we continue to struggle with multiple issues to keep the Health Fund sustainable. We are currently stable with 17 months of reserves. These reserves are critical. We are a self-insured plan. CIGNA administers the claims but our Fund pays them on a dollar-to-dollar basis.

Guidelines for self-insured plans recommend a minimum of 12 months of reserves to protect the Funds from various cost overruns. Actuarial projections show a gradual decline in reserves in the next few years and steps must be taken to keep the funding at an adequate level.

There are a number of factors which could affect our ability to maintain our current stability. The first, and most critical is the excessive cost of health care in the United States. Unlike the rest of the developed world, our system is primarily a fee-for-service arrangement with no accountability for outcomes. All group health plans struggle with high claims. Our Fund's costs are further impacted by extremely high out-of-network usage, particularly in musculoskeletal claims.

The Affordable Care Act brings its own set of cost drivers, such as the elimination of annual and lifetime limits on claims and the requirement for funds to pay certain per capita fees, which are costing us nearly a half million dollars in the current plan year (June 1,

2014 - May 31, 2015). In the near future, we will also be required to pay for all preventative services as well as for experimental treatments

Another significant cost driver has been our Self-Pay After COBRA (SPAC) benefit, which has allowed Fund participants with at least ten (10) years of pension credit to remain on the Equity-League plan once COBRA ran out by paving a designated premium. Now that the Affordable Care Act has eliminated pre-existing conditions as a basis for denial of coverage, the SPAC benefit has been modified and will only be available to those who meet certain new criteria. The FAQs on this can be found at equityleague.org.

The trustees have a federally mandated fiduciary duty to manage employer contributions to provide benefits for as many working members as possible. Despite the challenges described previously, it is our goal to maintain the current benefits for those who achieve eligibility under our contracts. Previous annual reports,

which have been published in

Equity News, have detailed the many initiatives that the Trustees have taken to contain costs. We will continue to work with the fund's professional advisors to analyze data with an eye toward maintaining stability.







The VITA program is available in-person by appointment or walk-in (first come, first served and dependent on available time slots) in the Equity Building at 165 West 46 Street on the 14th floor. The hours of operation are Monday, Wednesday, Thursday and Friday from 10:30 a.m. to 4 p.m.

Tax worksheets are now available for download in the VITA section located on the Member Portal. These worksheets, which comply with IRS law, are required for the VITA program and must be completed before your appointment.

If you are not able to visit VITA, you may still use the worksheets to organize your personal records and file your tax returns. Consult with your own tax preparer as to what you are required to do. Members with tax questions can call the VITA office at 212-921-2548 and speak to a member of the tax assistance team.

Other tax assistance is provided in Orlando at the Equity office and in Los Angeles at the Actors Fund VITA office

Los Angeles & New York City Broadway Gets Immunized For 2014-15

As the flu season arrived this winter, Broadway, Off-Broadway and beyond were prepared. Physician Volunteers for the Arts provided over 5,400 free seasonal flu vaccinations this fall and winter to the theatrical community. This annual free flu shot program, now in its 18th year, is sponsored by Actors' Equity Association and funded by Broadway Cares/Equity Fights AIDS.

New York City Spreading Holiday Cheer with the Falat Basket Project

When Dianne Eyerman first started volunteering with the Stephen J. Falat Basket Project in 1997, she remembered filling 250 children's baskets. This vear, for kids only a couple of months to 15 years old, 838 kids baskets were completed for the cause.

Beginning in 1985, the volunteer-run Stephen J. Falat Basket Project has filled gift baskets (clothing, candy, toys, toiletries and more) and delivered them to nearly 20 local New York hospitals and organizations to brighten the holidays of men, women and children living with HIV/AIDS. This season, volunteers brought 3,243 baskets to people in need.

The mission began when actor Stephen J. Falat visited a handful of patients at St. Luke's Hospital, donating Christmas baskets supplied through his own generosity. The next year. he organized the project through Actors' Equity Association and donated 150 baskets to other

AIDS charities. Falat passed away from complications from AIDS in 1991 and the Basket Project has been proudly continued in his memory.

For numerous volunteers, like Arne Gundersen, chair of the committee, and Greg Kayne, a coordinator, who have been part of the project since its inception, each year is like reuniting with family

"Working alongside of our fellow volunteers has turned into a family as the years have passed," said Eyerman, a Barry Manilow fan, who began volunteering when Manilow asked his International Fan Club to assist his production, Harmony, in getting to New York City by supporting Broadway in some way

"We keep coming back because we are committed to working on the baskets for children who might not receive any gifts and might not otherwise know the joys of the holiday," said Everman.

New York City Auditions Announced for AEA Scholarship Program at Singers Forum

After a brief hiatus, the AEA Scholarship Program at Singers Forum, under the auspices of EMGCollective, which administers the program, has returned to offer scholarships to Actors' Equity Association members living in the New York City area.

. The scholarship, which is a funded endowment from the organization, offers subsidized vocal training exclusively to members who apply, audition and are accepted. The subsidy covers almost 50 percent of the voice lesson, including a studio and accompanist. Without regard to age, ethnicity, gender and, for the most part, financial need, the scholarship is offered to qualified applicants to assist them in their quest for successful careers while maintaining the vocal health, strength and flexibility to attain long-term musical goals

New program members, once accepted, are permanently connected to the scholarship, if they choose. This means a student leaving on tour for a year is welcomed back into the program upon return to the New York City area.

This year, auditions will be held on: Monday, Februarv 9 from 3:30 -7 p.m. Thursday, February 12 from 10 a.m. - 6:30 p.m. Friday, February 13 from 2-6 p.m.

Callbacks will be held the week of February 16, 2015, and auditions will be held at Times Square Arts Center at 300 W. 43rd Street, Suite 508.

"Being able to study on a regular basis has bolstered my technique as well as my confidence," said Scott Tucker, a student within the program. "I have been able to work on music and material that would have been difficult to master without the eyes and ears of an amazing teacher, and I've been able to set performance goals and meet them.'


Fayetteville, Arkansas Arkansas' Theatresquared Joins In National Fundraising Efforts

With only 174 seats, the fiveperson company of Around the World in 80 Days at TheatreSquared in Fayetteville, Arkansas showed just how big they actually are by raising \$1,564 in just six performances during BC/EFA Week in December. Equity member Gil Brady, who played the leading role, Phileas Fogg, led the enthusiastic company - all of whom never missed an opportunity to jump in and fundraise. "It was a tremendous success," said Brady. "The people of Fayetteville were incredibly generous. We



expected to get maybe a couple hundred bucks total, but we'd come back with much more each show. It fueled our energy to do it again."

n 1993 I got my Equity Card not the way most actors do. I was a television star and my show, Who's the Boss, had just ended after eight years. I was at the Sunset Gower Studios cleaning out my office when I

got a call from Garry Marshall, I had known him from when I was doing Taxi and he was doing his great show, Happy Days. I ended up playing

shortstop for the Happy Days Baseball team; we traveled and played all over the country. He said that he had written a new four-character play titled, Wrong Turn at Lungfish, and wanted me to play the part of Dominic De Caesar. the tough boyfriend of the lead in



the play - which was eventually played by Laura San Giacomo and then Jami Gertz. Then, he hit me with the big news: maybe the greatest American actor would be playing the other lead. I asked who that was and, proudly, he said. "George C. Scott."

Rounding out the cast was Kelli Williams, who played the nurse. We did the play for six weeks in Los Angeles at the Coronet Theater [now the Largo at the Coronet] and then moved to New York City for a run at The Promenade Theatre [now closed] on 76th St. and Broadway. It was a great run, and working with and becoming friends with Scott was a revelation. Thanks for making me recall my beginning.

Broadway Cares/Equity Fights AIDS Breaks Records with Gypsy of the Year



ore than 250 Equity members came together December 8-9 for the 26th Annual Gypsy of the Year Competition. Sixty-four Broadway, Off-Broadway and national touring companies worked together to raise a record-breaking \$5,229,611 in the six-week fall fundraising campaign leading up to the event. The grand total was announced by Hugh Jackman, Nathan Lane and Judith Light after two performances of original dances, songs and skits at the New Amsterdam Theatre.

The top fundraiser was *The River*, starring Jackman, raising \$549,725. For the first time in history, the top two fundraising plays – *The River* and Terrence McNally's *It's Only a Play* with Mercer (1). Beginning with the word "Justice" written on a chalkboard wall, in a flurry of movement and flying chalk dust, the wall was transformed into a dove of peace as dancers personified the struagles of

racism, justice and inequality. The cast of *Pippin* earned cheers and runner-up honors. Nicolas Jelmoni and Charlotte O'Sullivan mesmerized the audience with incredible feats of strength and hand acrobatics.

The show's opening number celebrated the 40th anniversary of *The Wiz*, one of the first bigbudget Broadway musicals to feature an all-black cast and winner of seven Tony Awards in 1975. Triumphantly returning to the yellow brick road, Dee Dee Bridgewater, André De Shields and Ken Page, among others, were met with rapturous applause (2). In a fitting tribute to the groundbreaking show, Alton Fitzgerald White returned to close *Gypsy of the Year*, leading the "celebration cast" in a powerhouse rendition of "Home," the finale from *The Wiz*.

This year's Gypsy of the Year



also featured the cast of *Cinderella* performing a spirited ensemble tap entitled "The Rifferdancer." A parody of the heart-wrenching ASPCA public service announcements came with a *Avenue Q* spin, seeking help for puppets who are "suffering alone, waiting for you to help." The cast of *Kinky Boots* presented their show as if it were directed by John Doyle, while Wicked imagined the recent television production of Peter Pan with Lady Gaga as Tinker Bell **(3)**.

Sixteen national touring shows playing across the country raised more than \$1.7 million of the

campaign's grand total. A special dance presentation, representing the tours' remarkable fundraising efforts nationwide choreographed by Adam Fleming told the story of relationships sustained and broken on the road. This year's top musical



Day tour raised \$242,756. Top Broadway musical fundraiser was *Kinky Boots* with \$233,544 (4); followed by *Cabaret* with \$195,773 and *The Book of Mormon's* \$193,181. The Broadway play runner-up was *The Curious Incident of the Dog in the Night-Time*, earning \$115,980. Among the Off-Broadway shows, *Avenue Q* earned top honors, raising \$19,237.

My dear wife, Robin Ann Stockdale, passed quietly on January 11, 2015, in Kalamazoo, Michigan, at the age of 89.

In 1946, she played the leading role in *Soldier's Wife*, a production of the Kalamazoo Civic Players. That May, she joined a 14-member theatre group, The Village Players, which morphed into Jack Ragotzy's famed Barn Theatre of Augusta, Michigan. I was also in that company, just discharged from the Navy. We fell in love almost instantly and were married a year later

on July 4, 1947.

We were together for 68 years. Robin was never a stereotypical housewife or mother; she was so much more. She was my lover, my strength and support. She was editor for everything I wrote, including five published books and articles published in TheaterWeek. When I was "young, drunk and 21 and knew I could never die" (a quote from Thomas Wolfe's Look Homeward, Angel), Robin was my "lost lane into heaven." Without that "lane" of support. I don't believe I could have accomplished much.
